

Terms and Conditions

The Terms & Conditions were last updated on 19/08/2021. These are provided in English as a convenience, however only the Dutch version is legally binding.

1. Introduction

These Terms and conditions apply to this website and to the transactions related to our products and services. You may be bound by additional contracts related to your relationship with us or any products or services that you receive from us. If any provisions of the additional contracts conflict with any provisions of these Terms, the provisions of these additional contracts will control and prevail.

2. Binding

By registering with, accessing, or otherwise using this website, you hereby agree to be bound by these Terms and conditions set forth below. All of our domain services are performed on a pre-paid basis. A positive balance must be on your account prior to renewing a domain. You will be notified by email at least two weeks prior to the domain's renewal date. Failure to have sufficient funds available on your account at the time of the renewal indicates your intention to delete the domain according to the registries policies. Any charges related to reinstating the domain are solely yours.

8.2 Domain Fees

Domain fees are charged by the registries in their local currency. As a convenience to customers, we bill these fees in either EUROS or US Dollars as configured in your account. To adjust for currency fluctuations, these prices are adjusted on the first of each month using the exchange rates published by the European Central Bank on that date.
